 $\frac{\text{Whereas}}{\text{Months}}$  Section 44 (1) of the Public Service Act, 1961, provides that the  $3\overline{\text{Ist day}}$  of January in each year shall be a holiday on Nauru.

And Whereas the Cabinet approved on the 8th March, 1969, that the day following the 31st day of January in each year shall be a holiday on Nauru.

And Whereas in this year the 31st day of January falls on a Sunday, now therefore, I John Roger Ayers, Acting Chief Secretary, pursuant to the powers conferred on me by sub-section 4 of section 44 of the Public Service Act, 1961 - 1968, do hereby appoint Monday, 1st February, 1971, and Tuesday 2nd February, 1971, to be holidays to be observed by officers and employees of the Nauru Public Service.
