NAURU PHOSPHATE ROYALTIES TRUST ORDINANCE 1968

By virtue of the provisions of Section 30 (2) (c) of the above Ordinance I am required to publish or cause to be published a summary of the Annual Report of the Nauru Phosphate Royalties Trust in the Government Gazette.

I give below a summary of the Nauru Phosphate Royalties Trust Report dated 16th October, 1970, for the twelve months ended the 30th June, 1971:

Trustee:

Mr. R.S. Leydin was appointed a member of the Trust with effect from 24th October, 1969 in succession to Mr. T.A. Adams and during his temporary absence in Nauru from November 1969 to March 1970 Mr. G.F. Harris acted as deputy member in his place;

Mr. L.J. Lockie resigned as Chairman of the Trust with effect from 13th April, 1970 and Mr. R.S. Leydin was appointed as Chairman of the Trust effective from that date.

Funds Administered by the Trust:

Pursuant to the provisions of Section 18 and 19 of the Ordinance the Long Term Investment Fund and the Nauruan Land Owners Royalty Trust Fund are administered by the Trust and in addition certain other funds, being the Nauru Housing Fund, the Nauru Rehabilitation Fund and the Nauru Development Fund, are administered by the Trust pursuant to a direction given under Section 22 of the Ordinance. The Trust invests current funds of the Republic which are temporarily surplus to requirements as requested from time to time by the Secretary for finance.

Investment Policy:

The powers of the Trust relative to investment of moneys are those contained in Section 25 of the Ordinance; by virtue of the powers vested in it by the same Section, Cabinet from time to time has approved investment of funds in a manner or in manners considered appropriate in the circumstances presented to it; pursuant to the authority given by Cabinet the Trust has been seeking an opportunity to buy a suitable site in or near the City of Melbourne with a view to the erection of a building which would provide office accommodation for the Republic and its instrumentalities as well as office space which could be let for a good return on capital invested.

Income Tax:

During the year the Trust received advice that income derived from investments by the Trust in New Zealand are exempt from New Zealand income tax and exemption is also available from stamp duty on share transfers to and from the Trust. In Australia the income of those funds administered by the Trust on behalf of the Republic are exempt from Australian income tax but income of the Development Fund which is vested in the Nauru Local Government Council is subject to withholding tax; in the State of Victoria transfer of securities to and from the Trust on behalf of the Republic are exempt from stamp duty.

Audit of Trust Accounts:

An Audit Certificate without qualification has been issued by the auditors, Messrs. Coopers & Lybrand, Chartered Accountants, Melbourne.
