BY-ELECTION - CONSTITUENCY OF YAREN

ATTENTION of all persons in the District of Yaren is drawn to the by-election to be held on Saturday the 3rd of June, 1972, to fill one vacant seat in the Parliament of Nauru for the Constituency of Yaren.

NOTE

- 1. Voting is compulsory.
- 2. All Nauruans over 20 years living in the above Districts must be enrolled as electors before Saturday the 13th May.
- 3. All Nauruans who are on the rolls for the above District and who have moved to another District must apply to have their names transferred to the roll of their new District.
- 4. All persons wishing to nominate candidates may collect nomination forms from the Deputy Electoral Registrar/Seniór Legal Officer's Office and lodge the same before noon on the 20th May with the Returning Officer, the Chief Secretary.
- 5. Candidates need only be nominated by two electors and it is requested that no more than one nomination paper for each candidate be lodged with the Returning Officer. Only the first valid nomination paper for each candidate will be accepted.
