ROAD TRAFFIC SIGNS

"STOP SIGN"

In exercise of the powers conferred on me by Section 43(1) of the Motor Traffic Act 1937-1972 I hereby revoke the meaning of "Stop Sign" as designated in Gazette Notice No. 120/1967 and substitute the following meaning in its stead:

STOP SIGN

Meaning: Stop at the Sign and give way to traffic coming from your left and right before proceeding.
