Duties

Under the direction of the Courts of Nauru to supervise adults, young persons and children placed under his supervision by the Courts and to advise, assist and befriend them; also to make such enquiries as the Courts may require as to the circumstances of offenders with a view to assisting the Courts to determine the most suitable ways of dealing with their cases and also with a view to enabling the Courts to decide whether they are eligible for legal aid. Also such other duties as may be prescribed by I law from time to time.
