INTERPRETATION ACT 1971

ORDER

By virtue of the powers in that behalf vested in me under the provisions of Section 70 of the Interpretation Act 1971, I, AUSTIN BERNICKE, acting as the Minister responsible for the administration of Justice HEREBY ORDER that the following clerical errors appearing in the Motor Vehicle (Third Party Insurance) Ordinance Amendment Act 1972 (No. 16 of 1972) be rectified as directed hereunder:

Both in the stated purpose of the Act and in subsection (2) of Section 1 of the Act -

- (a) The word "Vehicle" shall appear as the word "Vehicles";
- (b) The words "Third Party" shall appear as the hyphenated word "Third-Party"; and
- (c) The word "Ordinance" appearing immediately after the symbol of a bracket shall appear as the word "Ordinances".
