#### PUBLIC SERVICE ACT 1961-1971

#### SECTION 27 (2) - NAURUAN BASIC WAGE

It is notified for general information that His Excellency President Hammer DeRoburt, O.B.E., M.P., has, under Section 27 Sub-section 2 of the Public Service Act 1961-1971, determined that the Nauruan Basic Wage should be varied in accordance with the movement in the Retail Price Index of Commodities on Nauru for the period from May 1974 to November 1974.

In consequence of the above, the Nauruan Basic Wage for male adults has increased by \$389 per annum, to \$2679 per annum, effective from 15th November, 1974 and this increase is applicable in the Public Service of Nauru.

The Basic Wage for adult females shall continue to be 75% of the Wage for adult males. Persons under the age of 21 years serving in the Public Service will continue to be paid at the same percentage of the adult rates as previously.

The rates applicable as from 15th November, 1974 are as set out below:-
