# VACANCY

Applications are called for candidates to undertake a training course for Air Hostesses in Australia and Nauru. Applications should be forwarded to the Acting Public Service Commissioner at the Chief Secretary's office, Administration Building, and must be received not later than 4.30 p.m. on Friday the 25th April, 1975.

Applicants;

- 1) Must be over 18 years,
- Must be under 9 stone in weight,
- 3) Must forward information on educational standard and present employment.

Present members of the Public Service will be given consideration to attend the training course.

The Acting Public Service Commissioner wishes to make it clear that applicatants chosen for the course do not necessarily thereby gain employment in the Public Service. The Candidates who undertake a successful course, however, will be considered for future service in Air Nauru.

Appropriate allowance will be paid for attendance at the Air Hostess Training Course in Australia.
