ROAD TRAFFIC SIGN

IN EXERCISE of the powers in that behalf vested in me by section 43(1) of the Motor Traffic Act 1937-1973, I, HAMMER DEROBURT, President of the Republic of

Nauru, <u>HEREBY SPECIFY</u> the design and meaning of the following traffic control sign:-

AIRCRAFT APPROACHING STOP SIGN:

Design: Dual red lights in horizontal, underneath of which appears

firstly, a white rectangular sign bearing the words "Aircraft Approaching" in black and secondly, a black rectangular sign bearing the words "Stop on Red Signal"

in white.

Meaning: Stop at sign when either one or both of the red lights

are lit and do not proceed until both red lights are

extinguished.
