APPOINIMENT OF OFFICER TO ACT AS

NAURU PHOSPHATE ROYALTIES TRUST ORDINANCE 1968

Funds Administered by the Trust

In accordance with the provisions of Sections 18 and 19 of the Ordinance the Long Term Investment Fund and the Nauru Landowners Royalties Trust Fund are administered by the Trust and in addition certain other funds being the Nauru Rehabilitation Fund and the Nauru Housing Fund are administered by the Trust pursuant to Section 20 of the Ordinance.

Investment Policy

The Trust has continued to invest available funds in the manner prescribed by Section 25 of the Ordinance as follows:

(a) in securities of, or guaranteed by, the Commonwealth or the States of Australia.

(b) in such other securities or classes of securities as Cabinet has approved.

(c) on fixed deposit in a Bank approved by the Cabinet, and

(d) in such other manner as Cabinet has approved.

invest moneys.

(a) in Short Term loans with authorised dealers on the Australian Official short term money market and the Republic of Nauru Finance Corporation (RONFIN),

(b) in Bills of Exchange accepted or endorsed by Australian Banks.

(c) on call or fixed deposit for up to 12 months with any Australian Bank or its wholly owned subsidiary to a maximum of \$2 million with any one such institution.

(d) on call or fixed deposit for up to 12 months with the Nauru-Branch of the Bank of New South Wales.

(e) in equities or first charge Company debentures on the Australian Stock Exchanges or recognised overseas Stock Exchanges.

(f) In first charge Company debentures not quoted on an Australian Stock Exchange provided that the total invested in any one fund does not exceed 25% of the total invested in first charge Company debentures.

Loan Investment

Two loans have been made to the Republic of Nauru Finance Corporation (RONFIN), the first in 1974 to finance the phosphate calcination plant, the second in 1975 for the purchase of an aircraft.

Puity Investments

A moderate equity buying programme has been maintained and a number of shares have also been sold realising a limited profiet on short term trading over the period and enabling the Trust's portfolio to show a small increase in value at a time when the Sydney All Ordinary Shares Index has recorded a fall.
