AUDIT ACT 1973DIRECTOR OF AUDIT (SALARY) REGULATIONS 1977

IN EXERCISE of the powers conferred upon me by Section 3 of the Audit Act 1973 the Cabinet hereby makes the following Regulations :

## SHORT TITLE

1. These Regulations may be cited as the Director of Audit (Salary) Regulations 1977.

## SALARY OF DIRECTOR OF AUDIT

2. The annual salary of the Director of Audit shall be the sum of Thirteenth thousand two hundred and forty-four Dollars Australian currency with effect from the 1st day of January 1976.

## EXPATRIATE LOADING ON SALARY

3. For so long as the Director of Audit shall be a person to whom Section 18(1) (a) (iii) of the Public Service Act 1961-1971 applied at the time of his appointment there shall be paid to him in addition to the salary mentioned in Regulation 2 a further sum of Nine hundred dollars Australian currency a year with effect from the 1st day of January 1976.
