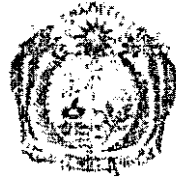

## PUBLIC SERVICE ACT 1961-1975

### (SECTION 15)

BY VIRTUE of the powers in that behalf vested in me under Section 15(1) of the Public Service Act 1961-1975, I BERNARD DOWIYOGO being the Minister responsible for the Public Service, HEREBY CREATE new offices, HEREBY ABOLISH offices, HEREBY RAISE AND LOWER the classification of offices, HEREBY ALTER the designation of offices as respectively appearing in the fifth column of the Schedule hereto TO THE EFFECT that as and from the 1st day of April, 1977, the offices, the classification of such offices and the designation of such offices in the Public Service of Nauru shall be as more particularly set out in the first, second, third and fourth columns of the Schedule hereto AND I HEREBY DIRECT that the provisions of Subsection (2) of Section 15 of the Act shall not apply to any alteration of the classification of any office as appearing in the Schedule hereto.

I HEREBY FURTHER DIRECT, that those officers currently holding the posts detailed in Schedule II hereto shall continue to be

paid at their current rates of salary, personal to holder, until such time as they are appointed to a different position or leave the Public Service.

I HEREBY FURTHER DIRECT, that with effect from the 1st day of July, 1977 the classifications shall be varied for those posts detailed in and in the manner shown in Schedule III hereto wherever such designated positions are established in the Public Service.
