FAMILY COURT ACT 1973

(Section 20)

THE SEAL OF THE FAMILY COURT

In pursuance of the powers vested in me by Section 20 of the Family Court Act 1973, I hereby direct that the seal of the Family Court is to be of rubber or other suitable material and of such a pattern that, when it is applied, it produces on the material to which it is applied an imprint of a regular twelve pointed star, approximately 11 millimetres across, in the centre of three concentric circles having respectively diameters of approximately 25 millimetres, 34 millimetres and 36 millimetres, with the words "OFFICIAL SEAL" written in capital letters within the innermost of those circles, the word "OFFICIAL" being above the star and the word "SEAL" below the star, and with the words "FAMILY COURT REPUBLIC OF NAURU" written in capital letters around the circumference of the innermost of those circles between the circumference of that circle and the circumference of the next innermost of those circles.
