# PUBLIC SERVICE ACT 1961-1975

#### VACANCY

Applications are invited from residents on Nauru both inside and outside the Public Service, for appointment, promotion or transfer to the following position:

Position :

Resident Magistrate/Registrar of the Supreme Court

Duties :

The Resident Magistrate who is also the Registrar of the Supreme Court, will be required to sit as Magistrate in the District and Family Courts and to act as Coroner and Registrar of the Supreme Court of Nauru. The Family Court will exercise jurisdiction over matrimonial causes and applications concerning adoptions. The Family Court's jurisdiction may also be extended to cover guardianship and custody of children as well as young offenders.

The Resident Magistrate will be required to supervise the work of the District and Family Courts and their administration and where advisable to review and revise such work.

Other duties may include the training of Police Prosecutors and assisting in instructing law students for Pleaders' examinations acting as Secretary of the Public Service Appeals Board and such other duties as may be determined by the Chief Secretary from time to time.

Qualifications

Applicants should be qualified as Solicitors or Barristers and should have experience as a Magistrate and/or as a Registrar of a Superior Court. Experience in the relevant type of training required to be undertaken would be an advantage.

Salary

Aust. \$12,204, \$12,684, \$13,164 to \$13,664 usually commencing at the first point of the scale. All salaries are payable in Australian currency and are tax free in

Nauru.
