#### CRIMINAL PROCEDURE ACT 1972

## SECTIONS 47 AND 48

#### DELEGATION OF POWERS AND DUTIES OF

#### DIRECTOR OF PUBLIC PROSECUTIONS

#### AND APPOINTMENT OF

#### PUBLIC PROSECUTOR

I, <u>DAVID GEOFFREY LANG</u>, being the Director of Public Prosecutions appointed pursuant to the provisions of Section 45 of the Criminal Procedure Act 1972 <u>DO HEREBY</u>, pursuant to provisions of Section 47 of the Criminal Procedure Act 1972, authorise <u>RODNEY JAMES HOOKER</u> an officer of the Department of Justice, to exercise all or any of the powers and rights vested, or duties imposed upon the Director of Public Prosecutions by virtue of the Sections 46, 180, 181 182 and 185 of the Criminal Procedure Act 1972, <u>AND FURTHER</u>, pursuant to Section 48 of the Criminal Procedure Act 1972 appoint <u>RODNEY JAMES HOOKER</u>, a public officer of the Department of Justice qualified to be admitted to practice as a Barrister and Solicitor to be Public Prosecutor in general.

<u>PROVIDED</u> that this authority shall not in any manner or form derogate from the powers and duties of the Director of Public Prosecutions.
