NURSING

Applications are invited from young women willing to be trained as nurses.

The Department of Health has appointed a Training Sister. will commence shortly to train suitable applicants as Nursing Orderlies. Persons, including those already employed as Nursing Orderlies, who show particular aptitude for nusing and are prepared to undergo longer and more intensive training will be selected for . a longer course leading to the qualification of Nurse (Nauruan). Training will consist of planned practical experience in the wards and attendance at lectures and demonstrations. It will be demanding but it will lead to a recognised qualification and ensure a future career for those who complete it satisfactorily.

At present there are vacancies for up to ten trainees.

Applicants must be at least 16 years of age. They should apply in writing to the Public Service Commissioner providing particulars of their educational standard and present or previous employment.
