APPOINTMENT BY CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf vested in it, under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE BURARO DETUDAMO, M.P., being the Minister for Finance and a Member of the Parliament of Nauru, to perform the duties and exercise the functions of the President in Nauru during the period of absence from the Republic of His Excellency President Hammer DeRoburt, O.B.E., M.P.
