ELECTION OF MEMBERS

CORRIGENDA to G.N. No.33/1979

1. In each place where the word "contributors" appears in Gazette Notice 33/1979, delete it and replace with the words "permanent officers" (that is to say an "officer" within the definition contained in Section 5 of the Public Service Act 1961-1975)".

2. Add to the said Gazette Notice at the foot thereof a note reading:-

"Note (not forming a formal part of the above Gazette Notice) Temporary officers and employees and contract officers may not stand for election, nominate a candidate or vote in the election."
