DUTIES:

- A) Courts Act 1972, Section 16:
- (a) to attend at such sittings of the District Court as the resident magistrate may direct;
- (b) to prepare summonses, warrants, decrees, orders, convictions, recognizances, writs of execution and other documents and to submit them to the resident magistrate, or, if the resident magistrate so directs, to another magistrate, for signature;
- (c) to issue civil process if authorised by rules of court;
- (d) to maintain case files and registers, to record judgements and orders of the District Court and to make, or cause to be made, copies of proceedings where required to do so;
- (e) to receive all fees, fines and penalties, and all other moneys paid or deposited in respect of proceedings in the District Court, and to keep an account of them;

- (a) to attend at such sittings of the Court as the Chairman may direct;

- (b) to prepare summonses, warrants, decrees, orders, recognizances; writs of excecution and other documents and to submit them to the Chairman or, if the Chairman so directs, to another member of the Court, for signature;
- (c) to issue process if authorised by rules of Court;
- (d) to maintain case files and registers, to record judgements and orders of the Court and to make, or cause to be made, copies of proceedings when required to do so;
- (e) to receive all fees, fines and penalties, and all other moneys paid or deposited in respect of proceedings in the Court, and to keep an account of them;
- (f) to perform, or cause to be performed, such other duties connected with the Court as may be assigned to him by the Chairman.
- C) Inquest Rules 1977, Rule 2:
- 1) The Clerk of the District Court shall keep an indexed register of all deaths reported to the resident magistrate under paragraph (b) of subsection (1) of section 4 of the Act; the register shall contain the particulars specified in the First Schedule to these Rules.
- 2) The Clerk of the District Court shall keep an indexed register of all inquests held by the resident magistrate under the Act; the register shall contain the particulars specified in the Second Schedule to these Rules

QUALIFICATIONS:

Reasonable educational standards with ability to speak and interpret both Nauruan and English.

APPLICATIONS FOR NURSING TRAINING

A 3-years course of training for Nurses will commence at Nauru General Hospital at the beginning of February 1980.

Applications, addressed to the Director of Health and Medical Services, Nauru, should be submitted by 21 December 1979.

Applications will be received from students who will be completing school this year, from Nursing Orderlies and from other persons interested in nursing as a career.

Applicants must be at least 16 years of age. Education to Form 5 is preferred. However applicants with lesser qualifications but with relevant experience will be considered.

Training will consist partly of lectures, demonstrations and practical work in the classroom and partly of practical experience in the wards and other branches of the hospital where trainees will work with the regular nursing staff.
