### PROCLAMATION

# PROHIBITION OF IMPORTATION OF FIREARMS AND AMMUNITION

WHEREAS by section 2 of the Customs Regulations Ordinance 1922-1936 the Customs Ordinance 1921 for the Territory of New Guinea was adopted as an Ordinance of Nauru so far as it could reasonably be made applicable to the circumstances of Nauru, and was not repugnant to or inconsistent with the provisions of any Act, Ordinance, law, regulation, rule, order or proclamation having the force of law that had been or might thereafter express to extend to or apply to or made or promulgated in Nauru

AND WHEREAS section 46 of the Customs Ordinance 1921 for the Territory of New Guinea provided that all goods the importation of which is prohibited by proclamation by the Administrator should be prohibited imports

AND WHEREAS by virtue of the provisions of Article 86(2) of the Constitution of Nauru the power to proclaim the importation of goods of a specified kind as prohibited imports under and by virtue of section 46 of the Customs Ordinance 1921 of New Guinea is vested in me, LEO DEP KEKE, Minister for Justice of G.N. No. 40/1980(Cont'd)

the Republic of Nauru

NOW, THEREFORE, I the said LEO DEP KEKE, DO HEREBY PROHIBIT the importation of ammunition (meaning and including all varieties of gunpower and any other explosive agent used or that can be used with firearms and all shot or other projectiles, and any other articles ordinarily used with firearms, as well as all materials that can be used in the preparation of ammunition), and firearms (meaning every kind and variety of gun or pistol used or intended for the discharge of projectiles of any kind and also any part of any such gun or pistol) (unless the importation in question has been previously authorised in writing by the Minister for Justice).
