The assignment of business of Goverrment of Nauru as set out above is in addition to and not in substitution for the business of the Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the business of Government shall be effective during the absence from the Republic of His Excellency President Hammer DeRobourt, O.B.E., M.P.

CRIMINAL PROCEDURE ACT 1972

SECTION 48.

APPOINTMENT OF PUBLIC PROSECUTOR.

I, DAVID GEOFFREY LANG, Director of Public Prosecutions of the Republic of Nauru, in exercise of my powers under Section 48 (1) of the Criminal Procedure Act 1972 hereby appoint Dr. VENKATESWARA SUBRAMANIAN MANI, a public officer of the Department of Justice, who is a barrister and solicitor, to be a public prosecutor generally and I authorise him pursuant to Section 47 of the Criminal Procedure Act 1972 to exercise on my behalf all or any of the powers and rights vested in or duties imposed upon, me, by Sections 46, 180, 181, 182 and 185 of the Criminal Procedure Act 1972 provided that this authorisation shall not prevent me from myself exercising such powers and provided further that in conducting a prosecution Dr. Mani shall be subject to my express directions as Director of Public Prosecutions.
