COURT FEES (AMENDMENT) RULES 1982

IN EXERCISE of the powers conferred on me by section 76 of the Civil Procedure Act, 1972, I hereby make the following rules of court -

TITLE

 These Rules may be cited as the Court Fees (Amendment) Rules 1982.

THE PRINCIPAL RULES

2. In these Rules "the principal Rules" means the Court Fees Rules 1979.

DEPARTMENT OF ISLAND DEVELOPMENT & INDUSTRY

(Directorate of Civil Aviation)

The Department of Civil Aviation has vacancies for twelve (12) AIR HOSTESSES and invites applications from young women who are willing to undergo training as Air Hostesses with a view to employment by Air Nauru.

Applicants must:

- a) be eighteen years of age and over
- b) be under nine stone in weight
- supply particulars of their educational standard and present or previous employment.

Members of the Public Service are eligible to apply.

Acceptance for training as an Air Hostess does not in itself mean that applicants will be appointed to the Public Service. Those who complete the course successfully will however be eligible for employment by Air Nauru, either on a permanent or temporary basis.

While undergoing training in Australia successful applicants will be provided with accommodation and a subsistence allowance. On appointment as Air Hostesses after completion of training they will be paid commencing salaries as follows:

18 years of age:

\$3192 per annum

19 years of age:

\$3724 per annum

20 years of age:

\$4788 per annum

21 years and over:

\$5320 per annum

Applications should be forwarded to the Public Service Commissioner before 4.30 pm. on Friday 10th September, 1982.
