ANIMALS (PRESCRIBED FEES) REGULATIONS 1982

In Exercise of the powers conferred on it by Section 20 of the Animals Act 1982, the Cabinet has made the following Regulations-

# 1. Short Title

These Regulations may be cited as the Animals (Prescribed Fees) Regulations 1982.

#### 2. Commencement

These Regulations shall be in force from the date on which the Act comes into force.

# Interpretation

In these Regulations, "the Act" means the Animals Act 1982.

## 4. Prescribed Fees

Where any provision in the Act or in any regulations made thereunder provides for the payment of a prescribed fee in respect of a particular matter, the fee to be paid shall be the fee set out in the Schedule hereto for that matter and shall be payable to, and receivable by, the Licensing Authority under Section 19 subsection (1) of the Act.

## 5. Amendments or Alterations to the Regulations

These Regulations (including the Schedule hereto) are subject to any amendments and/or modifications which the Cabinet may, from time to time, deem necessary and expedient.

## ANIMALS (FORMS) REGULATIONS 1982

In Exercise of the powers conferred on it by Section 20 of the Animals Act 1982, the Cabinet has made the following Regulations-

# 1. Short Title

These Regulations may be cited as the Animals (Forms) Regulations 1982.

# 2. Commencement

These Regulations shall be in force from the date on which the Act comes into force.

## 3. Interpretation

In these Regulations, "the Act" means the Animals Act 1982.

## 4. Prescribed Form of Application for Licence

Application for grant of a licence under Section 4 of the Act shall be made in the form prescribed herein in the First Schedule to these Regulations.

## 5. Prescribed Form of Licence

Licence to be granted by the Licensing Authority under Section 4 of the Act shall be in the form prescribed herein in the Second Schedule to these Regulations.

## 6. Prescribed Form of Health Certificate

The certificate to be issued under Section 5(2) of the Act by the Director of Health and Medical Services or by a person nominated by the Director shall be in the form prescribed in the Third Schedule to these Regulations.

## 7. Strict Compliance with Forms not necessary

Strict compliance with the forms contained in the First and the Third Schedule to these Regulations is not necessary, and substantial compliance, to the satisfaction of the Licensing Authority, shall be sufficient.

#### 8. Directions in the Forms

- (1) The forms prescribed by these Regulations shall be completed in accordance with such directions as are specified in the forms so prescribed.
- (2) The application form prescribed under the First schedule shall not be considered duly filled in and lodged, unless the documents in support of the application, as required by the prescribed form and/or by the Licensing Authority, accompany the application.

#### 9. Amendments or Alterations to the Regulations

These Regulations (including the Schedules hereto) are subject to any amendments and/or modifications which the Cabinet may, from time to time, deem necessary and expedient.
