NAURU POLICE FORCE ACT (SECTION 4)

I, JOSEPH DETSIMEA AUDOA, Minister for Justice of the Republic of Nauru, by virtue of the powers vested in me under Section 4, sub-section (1) of the Nauru Police Force Act 1972 (hereinafter referred to as "The Act"), DO HEREBY establish with effect from 14th day of October 1982, a body of Reserve Officers to be called the Nauru Police Force Reserve, consisting of such police officers as may be appointed by the Director of Police, pursuant to Section 7 of the Act.

POLICE REGULATIONS 1972 (REGULATION 19)

I, JOSEPH DETSIMEA AUDOA, Minister for Justice of the Republic of Nauru, by virtue of the powers vested in me under Regulation 19 of the Police Regulations 1972 made under the Nauru Police Force Act 1972, DO HEREBY direct that each of the Reserve Officers of the Nauru Police Force Reserve shall be paid normal hourly overtime rate payable to a Constable for each hour or part of an hour of duty or training which he performs or undergoes as an officer of the Nauru Police Force Reserve.
