## SCHOLARSHIP EXAMINATIONS

The Honourable the Minister for Health & Education has directed that the Examinations for the award of lower and upper age scholarships be held on Tuesday 26th July. The lower age scholarship will be for secondary education overseas while the upper age scholarship will be for secondary and/or secondary technical education overseas. The scholarships will be taken up at the beginning of the 1984 school year.

Children who are members of the Nauruan Community may compete for the awards.

Students in Form 1 in 1983 are eligible to sit for the lower age scholarship examination. However a child who will be older than 13 years 6 months on December 31st 1983 will be awarded a scholarship only under special circumstances.

Students in Form 4 in 1983 are eligible to sit for the upper age scholarship examination. Any student older than 17 years on December 31st 1983 will be awarded a scholarship only under special circumstances.

The examination for both lower age and higher age scholarships will consist of the following papers:

School Principals will be submitting lists of students who have nominated to sit for the examination.

Students who are currently attending schools overseas as private students may sit for the examination provided they meet the requirements outlined above. These students must return to Nauru in order to sit for the examination, but at their own expense.
