#### NAURU SUPERANNUATION BOARD

## ELECTION OF A MEMBER

WHEREAS the Cabinet in exercise of its powers under Section 7(2) of the Superannuation Act 1966-1973 and by Gazette Notice No.446/1983 dated the 19th day of October, 1983 determined the manner of the Election of a Member to the Superannuation Board to be elected by the Superannuation Board to be elected by the contributors;

AND WHEREAS by the said Gazette Notice the Cabinet also determined that the Election was to be held on Monday the 7th day of November, 1983 and that the nominations were to be lodged with the Returning Officer before 4.45 p.m. on Monday the 31st October 1983;

AND WHEREAS no valid nomination was lodged on the aforesaid day;

AND WHEREAS it has become necessary that the date and time of Election to be held and nominations to be lodged be determined again;

NOW THEREFORE the Cabinet in exercise of its powers under Section 7(2) of the Superannuation Act 1966-1973 and in partial modification of Gazette Notice No.446/1983 dated the 19th day of October, 1983 hereby determines that -

- 1. The Election of a Member to the Superannuation Board to be elected by contributors shall be held on Friday the 16th day of December, 1983 between the hours of 2.00 p.m. and 4.30 p.m.;
- 2. The nominations must be lodged with the Returning Officer no later than 4.45 p.m. on Friday the 9th day of December, 1983.
- 3. In all other respect, the Election shall be conducted as and in the manner specified in Gazette Notice No.446/1983 dated the 19th day of October, 1983.
