NOTIFICATION UNDER NLGC ORDINANCE 1951-1967

- 1. The Nauru Local Government Council having decided to hold a by-election to fill the vacancy of the councillor of Yaren District caused by the death of Councillor J.D. Audoa, hereby notifies under Section 34(2) of Nauru Local Government Council Ordinance 1951-1967 that the said by-election shall be held on 30th day of June, 1984, at Yaren Primary School between 1 p.m. to 6 p.m. and that the Nomination Day shall be the day fourteen days preceding the date of election i.e. 16th June, 1984, not later than 12 noon.
- By virtue of the power vested in it under Section 3 of the Nauru Local Government Council Ordinance 1951-1967, the Council hereby appoints Mr. J.K. Rai to be the Returning Officer for the purpose of holding by-election for the Yaren District to be held on 30th day of June, 1984.
- 3. By virtue of the power vested in it under Section 14(1) of the Nauru Local Government Council 1951-1967 the Council having appointed Mr. H.R. TEMAKI, Registrar hereby directs that the Electoral Roll for the District of Yaren shall be kept open until 16th June, 1984, for purpose of exercising power under Section 14 A and 17 of the Nauru Local Government Council Ordinance 1951-1967.
