#### CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

N EXERCISE of the powers in that behalf vested in His Excellency the resident, under Article 23 of the Constitution of Nauru, I, BURARO DETUDAMO, being the Minister Exercising the functions of His Excellency the President in Nauru under and by virtue of appointment as such by cabinet under Article 21 of the Constitution of Nauru, hereby assign to the Ministers of the cabinet of Nauru, as set out below the responsibilities of the business of the Government of Nauru as set out opposite their names:

The assignment of the business of the Government of Nauru as set out above is in addition to and not in substitution for the business of the Government of Nauru already assigned to the said Minister. The above assignment of responsibility for the business of government shall be effective during the absence from the Republic of The Honourable Kenas Aroi, M.P. Minister for Finance.

#### DEPARTMENT OF EDUCATION

#### SCHOLARHIP EXAMINATIONS

The Honourable the Minister for Health & Education has directed that the Examinations for the award of lower and upper age scholarships be held on Wednesday 25th July. The lower age scholarship will be for secondary education overseas while the upper age scholarship will be for secondary and/or secondary technical education overseas. The scholarships will be taken up at the beginning of the 1985 school year. Children who are members of the Nauruan Community may compete for the awards.

Students in Form 1 in 1984 are eligible to sit for the lower age scholarship examination. However a child who will be older than 13 years months on December 31st 1984, will be awarded a scholarship only under special circumstances.

Students in Form 4 in 1984 are eligible to sit for the upper age scholarship examination. Any student older than 17 years on December 31st 1984 will be awarded a scholarship only under special circumstances.

The examination for both lower and higher age scholarships will consist of the following papers:

WRITTEN EXPRESSION Pt 1 30 mins

MATHEMATICS 50 mins

READING 50 mins

WRITTEN COMPREHENSION Pt 11 30 mins

chool Principals will be submitting lists of students who have nominated to sit for the examination.

Students who are currently attending schools overseas as private students may sit for the examination provided they meet the requirements outlined above. These students must return to Nauru in order to sit for the examination, but at their own expense.
