CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS

OF GOVERNMENT

The assignment of business of Government of Nauru as set out above is in addition to and not in substitution for the business of Government of Nauru assigned to the said Ministers. The above assignments of responsiblity for the business of Government shall be effective during the absence from the Republic of His Excellency President HAMMER DEROBURT, G.C.M.G., O.B.E., M.P.
