CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS

OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in His Excellency the President, under Article 23 of the Constitution of Nauru, I, <u>HAMMER</u> <u>DEROBURT</u>, President of the Republic of Nauru, hereby assign to the Ministers of the Cabinet of Nauru, set out below, the responsibilities for the business of the Government of Nauru as set out opposite their names:

MINISTERS OF CABINET

Minister for Works and Community Services

Minister for Health and

Education

BUSINESS OF GOVERNMENT

The Portfolio of the President, External and Internal Affairs, the Public Service in relation to the business of Government to be undertaken in Nauru by the said Minister.

The Portfolio of the Minister for Finance in relation to the business of Government to be undertaken in Nauru by the said Minister.

The assignment of business of Government of Nauru as set out above is in addition to and not in substitution for the business of Government of Nauru already assigned to the said Ministers. The above assignments of responsibility for the business of Government shall be effective during the absence from the Republic of His Excellency President HAMMER DEROBURT, G.C.M.G., O.B.E., M.P. and the Honourable Kenas Aroi, M.P., Minister for Finance.

CONSTITUTION OF NAURU

APPOINTMENT OF CABINET UNDER ARTICLE 21

IN EXERCISE of the powers in that behalf vested in it, under Article 21 of the Constitution of Nauru, CABINET HEREBY APPOINTS THE HONOURABLE BURARO DETUDAMO, being the Minister for Works and Community Services and a member of the Cabinet of Nauru, to perform the duties and exercise the functions of the President in Nauru during the period of absence from the Republic of His Excellency President HAMMER DEROBURT, G.C.M.G., O.B.E., M.P.

CRIMINAL PROCEDURE ACT 1972

(SECTIONS 47 & 48)

DELEGATION OF DIRECTOR OF PUBLIC PROSECUTIONS' POWERS AND APPOINTMENT OF PUBLIC PROSECUTOR

I, <u>SACHI</u> NATH CHOWDHURY, in exercise of my powers under Section 47 of the Criminal Procedure Act 1972, authorise that all or any of the powers and rights vested in, or duties imposed upon me, by Section 46, 180, 182 and 185 of the Criminal Procedure Act 1972, may be exercised by GOKARAN NATH SAKSENA, a Public Officer of the Department of Justice, and so that the exercise of those powers and richts and the performance of those duties by the said GOKARAN NATH SAKSENA in my name shall then operate as if they had been exercised or performed by me PROVIDED that I shall not cease to be able to exercise any of my powers by reason only of I having made this authorization.

FURTHER, AND IN EXERCISE of my powers under Section 48(1) of the Criminal Procedure Act 1972, I APPOINT the said GOKARAN NATH SAKSENA, being a Public Officer of the Department of Justice, who is qualified to be admitted to practise as a Barrister and Solicitor, to be a Public Prosecutor generally.

CRIMINAL PROCEDURE ACT 1972

(SECTIONS 47 & 48)

DELEGATION OF DIRECTOR OF PUBLIC PROSECUTIONS' POWERS AND APPOINTMENT OF POLICE PROSECUTOR

I, <u>SACHI NATH CHOWDHURY</u>, in exercise of my powers under Section 47 of the Criminal Procedure Act 1972, authorise <u>ANDRE NOTTE</u>, Acting Sergeant IInd Class, a Police Officer of the Nauru Police Force to appear in the Court on behalf of the Director of Public Prosecutions and to exercise all or any of the powers and rights vested in or duties imposed upon him by Section 181 and 182 of the Criminal Procedure Act 1972. That the exercise of those powers and rights and the performance of those duties by the said ANDRE NOTTE in my name shall operate, as if they had been exercise or performed by me provided that I shall not cease to be able to exercise any of my powers by reason only of I having made this authorization.

FURTHER, AND IN EXERCISE of my powers under Section 48(3) of the Criminal Procedure Act 1972, I APPOINT the said ANDRE NOTTE BEING a police officer of the Nauru Police Force to be a Police Prosecutor.
