CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, HAMMER DEROBURT, PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU, SET OUT BELOW, THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR NAMES:

MINISTERS OF CABINET

MINISTER FOR WORKS AND COMMUNITY SERVICES

MINISTER FOR FINANCE

BUSINESS OF GOVERNMENT

THE PORTFOLIO OF THE PRESIDENT, EXTERNAL AND INTERNAL AFFAIRS AND THE PUBLIC SERVICE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE PORTFOLIO OF THE MINISTER FOR ISLAND DEVELOPMENT AND INDUSTRY IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTERS. THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, G.C.M.G., O.B.E., M.P.

CIVIL PROCEDURE ACT 1972

CIVIL PROCEDURE (AMENDMENT) RULES 1985

In exercise of the powers conferred on me by Section 76 of the Civil Procedure Act 1972, I hereby make the following rules of Court to amend the Civil Procedure Rules 1972.

SHORT TITLE

- 1. (i) These rules may be cited as the Civil Procedure (Amendment) Rules 1985.
 - (ii) They shall come into operation on the 30th day of May 1985.
- 2. The Schedule to the Civil Procedure Rules 1972 is amended by -
 - (i) adding the following entry thereto in the respective columns thereof:-

"63 Special Case";

(ii) adding the following new Order 63 after the existing Order 62:

ORDER 63

SPECIAL CASE

1. Questions of Law: Power to draw inferences— The parties to any cause or matter before any Court or Board constituted under Part VII of the Constitution may concur in stating the questions of law arising therein in the form of a special case for the opinion of the Supreme Court. Every such special case shall be divided into paragraphs numbered consecutively, and shall concisely state such facts and documents as may be necessary to enable the Court to decide the questions raised thereby.

Upon the argument of such case the Court and the parties shall be at liberty to refer to the whole contents of such documents, and the Court shall be at liberty to draw from the facts anddocuments stated in any such special case any inference, whether of facts or law, which might have been drawn therefrom if proved at a trial.

2. Preliminary question of law: Stay proceedings - If appear to any Court or a Judge thereof or any Board constituted pursuant to Part VII of the Constitution that there is in any cause or matter a question of law which it would be convenient to have decided by the Supreme Court, the Court or Judge or Board may make an order accordingly, and may apply to the Supreme Court to have such question of law raised for the opinion of the Court, either special case or in such manner as the Court may deem expedient, and all such other or further proceedings as the decision of such question of law may render unnecessary may thereupon be stayed."
