The above assignments of responsibility for the Business of Government shall be effective during the absence from The Republic of His Excellency President HAMMER DEROBURT , G.C.M.G., O.B.E., M.P.

The above assignments of responsiblity for the Business of Government shall be effective during the absence from The Republic of His Excellency President HAMMER DEROBURT, G.C M.G., O.B.E., M.P. and The Honourable KENAS AROI, M.P., Minister for Finance.
