CONSTITUTION OF NAURU

ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS

OF GOVERNMENT

IN EXERCISE OF THE FOWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, <u>HAMMER DEROBURT</u>, PRESIDENT OF THE REPUBLIC OF NAURU, SET OUT BELOW, THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE HIJ NAME:

MINISTER OF CABINET

BUSINESS OF GOVERNMENT

MINISTER FOR WORKS AND COMMUNITY SERVICES THE PORTFOLIO OF THE MINISTER FOR FINANCE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDERTAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENT OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF THE HONOURABLE KENAS AROI, M.P., MINISTER FOR FINANCE.

APPOINTMENT OF ACTING GENERAL MANAGER

<u>IN EXERCISE</u> OF THE POWERS VESTED IN ME UNDER SECTION 18, SUB-SECTION (4) OF THE BANK OF NAURU ACT 1976, <u>I</u>, <u>HAMMER</u> <u>DEROBURT</u>, PRESIDENT AND MINISTER RESPONSIBLE FOR ISLAND DEVELOPMENT AND INDUSTRY, <u>DO HEREBY</u> APPOINT MR N. GOSWAMI TO ACT AS THE GENEFAL MANAGER OF THE BANK OF NAURU WITH EFFECT FROM 20TH JULY 1986, UNTIL SUCH TIME AS THE CABINET MAY FIND IT CONVENIENT TO APPOINT A SUITABLE PERSON TO BE THE GENERAL MANAGER OF THE BANK.
