# ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY, THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BURARO DETUDAMO, BEING THE MINISTER EXERCISING THE FUNCTIONS OF HIS EXCELLENCY THE PRESIDENT IN NAURU UNDER AND BY VIRTUE OF APPOINTMENT AS SUCH BY CABINET UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, HEREBY ASSIGN TO THE MINISTER OF THE CABINET OF NAURU AS SET OUT BELOW THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE HIS NAME:
