# CONSTITUTION OF NAURU ASSSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS

OF GOVERNMENT

IN EXERCISE of the powers in that behalf vested in His Excellency the President, under Article 23 of the Constitution of Nauru, I, BURARO DETUDAMO, being the Minister exercising the functions of His Excellency the President in Nauru under and by virtue of appointment as such by Cabinet under Article 21 of the Constitution of Nauru, hereby assign to the Ministers of the Cabinet of Nauru, as set out below the responsibilities of the business of the Government of Nauru as set out opposite their names:

#### MINISTER OF CABINET

## BUSINESS OF GOVERNMENT

Minister for Health and Education

The portfolio of the Minister for Finance in relation to the business of Government to be undertaken in Nauru by the said Minister.

Minister for Justice

The portfolio of the Minister for Island Development and Industry in relation to the business of Government to be undertaken in Nauru by the said Minister.

The assignment of the business of the Government of Nauru as set out above is in addition to and not in substitution of the business of the Government of Nauru already assigned to the said Minister. The above assignment of responsibility for the business of Government shall be effective during the absence from the Republic of His Excellency President Hammer DeRoburt, G.C.M.G., O.B.E., M.P. and the Honourable Kenas Aroi, M.P., Minister for Finance.

## NOTICE OF LANDS APPEAL

Published hereunder is the decision of the Supreme Court of the Republic of Nauru in Land Appeal No.2 of 1984 decided on 19th July, 1984 by His Honour the Acting Chief Justice, Mr.B.J.M. Kerr in relation to determination of Nauru Lands Committee in respect of Land owned by the Late AIGENOUDI.

The Appeal in respect of a quarter share in that portion of Land described as QUEIRANG portion No.25 of Anabar District G.N.No.20/1984 is therefore allowed and the Nauru Lands Committee is directed to apportion the shares on the basis that ETTO AINGIMEA and EIDIBINAOMAT TEBOUA are entitled to share with the other beneficiaries on the sabasis as for the other seven portions of Land bearing in mind that the deceased's entitlement is 1/4 share only in respect of the relevant portion of Land.
