COMMISSIONS OF INQUIRY ORDINANCE 1948-1967 SECTION 3 (1) COMMISSION FOR REVIEW OF PARLIAMENTARY SALARIES AND ALLOWANCES

<u>PURSUANT TO</u> the powers vested in it by Section 3(1), Commissions of Inquiry Ordinance 1948-1967, the Cabinet <u>DOES HEREBY</u> issue a Commission to the Acting Chief Justice of the Republic of Nauru, Sir Gaven Donne, as the Sole Commissioner to inquire into and make recommendations on the following matters, that is to say:-

- (a) whether the salaries and allowances payable to the persons holding the offices of President, Ministers, Speaker and Member of Parliament under the provisions of the Parliamentary Salaries and Allowances Act 1971 are adequate and appropriate:
- (b) if the answer to the above question is in the negative, what recommendations the Commission has to render the provisions of law adequate and appropriate;

AND, the Cabinet further requires and authorises the said Commissioner to have regard in the said Inquiry to the duties and responsibilities of the respective offices and to investigate and ascertain such other facts as he considers to be relevant to the subject-matter of the said Inquiry;

AND, the Cabinet further authorises the Commissioner to appoint a suitable person as Secretary to him in order to assist him in respect of administrative matters in relation to the Commission;

AND, the Cabinet further requires the said Commissioner upon completion of his tasks under the present Commission, to submit to the Cabinet his report and recommendations at an early date.
