### CONSTITUTION OF NAURU

### ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, BURARO DETUDAMO, BEING THE MINISTER EXERCISING THE FUNCTIONS OF HIS EXCELLENCY THE PRESIDENT IN NAURU UNDER AND BY VIRTUE OF APPOINTMENT AS SUCH BY CABINET UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, HEREBY ASSIGN TO THE MINISTER OF THE CABINET OF NAURU AS SET OUT BELOW THE RESPONSIBILITIES OF THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE HIS HAME:

#### MINISTER OF CABINET

MINISTER FOR HEALTH AND EDUCATION

### BUSINESS OF GOVERNMENT

THE PORTFOLIO OF THE MINISTER FOR FINANCE IN RELATION TO THE BUSINESS OF GOVERNMENT TO BE UNDER->TAKEN IN NAURU BY THE SAID MINISTER.

THE ASSIGNMENTS OF BUSINESS OF GOVERNMENT OF NAURU AS SET OUT ABOVE IS IN ADDITION TO AND NOT IN SUBSTITUTION FOR THE BUSINESS OF GOVERNMENT OF NAURU ALREADY ASSIGNED TO THE SAID MINISTER. THE ABOVE ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT SHALL BE EFFECTIVE DURING THE ABSENCE FROM THE REPUBLIC OF THE HONOURABLE KINZA CLODUMAR, M.P. MINISTER FOR FINANCE.
