## CONSTITUTION OF NAURU ARTICLE 25 (1) APPOINTMENT OF ACTING CHIEF SECRETARY

It is notified for general information that Cabinet, at its meeting held on 29th November, 1988, pursuant to Article 25, clause (1) of the Constitution of Nauru, has approved the appointment of Mr. G. Jayaraman, the Republic's Secretary for Finance, to concurrently act as:
