CONSTITUTION OF NAURU APPOINTMENT OF CABINET UNDER ARTICLE 21

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN IT, UNDER ARTICLE 21 OF THE CONSTITUTION OF NAURU, CABINET HEREBY APPOINTS THE HONOURABLE BURARO DETUDAMO, BEING THE MINISTER FOR WORKS AND COMMUNITY SERVICES AND A MEMBER OF THE CABINET OF NAURU, TO PERFORM THE DUTIES AND EXERCISE THE FUNCTIONS OF THE PRESIDENT IN NAURU DURING THE PERIOD OF ABSENCE FROM THE REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, G.C.M.G., O.B.E., M.P.

CONSTITUTION OF NAURU ASSIGNMENT OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENT

IN EXERCISE OF THE POWERS IN THAT BEHALF VESTED IN HIS EXCELLENCY THE PRESIDENT, UNDER ARTICLE 23 OF THE CONSTITUTION OF NAURU, I, HAMMER DEROBURT, PRESIDENT OF THE REPUBLIC OF NAURU, HEREBY ASSIGN TO THE MINISTERS OF THE CABINET OF NAURU, SET OUT BELOW, THE RESPONSIBILITIES FOR THE BUSINESS OF THE GOVERNMENT OF NAURU AS SET OUT OPPOSITE THEIR NAMES:-

THE ABOVE ASSIGNMENTS OF RESPONSIBILITY FOR THE BUSINESS OF GOVERNMENTS SHALL BE EFFECTIVE DURING THE ABSENCE FOR THE REPUBLIC OF HIS EXCELLENCY PRESIDENT HAMMER DEROBURT, G.C.M.G., O.B.E., M.P., AND THE HONOURABLE KINZA CLODUMAR, M.P., MINISTER FOR FINANCE.
