#### SCHOLARSHIP EXAMINATIONS 1989

The Honorable, the Minister for Health and Education has approved the following arrangements for the Scholarship Examinations 1989. Only children who are Nauruan citizens may compete for the awards. Each child may compete only once for each scholarship level.

1. LOWER AGE SCHOLARSHIP

- a) Students in Grade 6 are eligible to sit for the Australian Co-operative Entry Program. Provisional awards may be made on the result of these tests, to be confirmed subject to satisfactory completion of the Grade 6 year, 1989. However a child who will be older than 12 years and 6 months on December 31, 1989 will be awarded a sholarship only under special circumstances. Registration forms have been distributed through the shools. Additional forms are available from the Education Directorate but registration should be completed before mid-February. The tests will be held on Saturday 8th April, 1989.
- b) Students in Form 1 are eligible to sit for the Lower Age Scholarship Examination. Provisional awards may be made on the result of this examination, to be confirmed subject to satisfactory completion of the Form 1 year, 1989. However, a child who will be older than 13 years and 6 months on December 31, 1989 will be awarded a Scholarship only under special circumstances. After 1989 the Lower Age Scholarship Examination will bw wholly replaced by the Grade 6 programme. Lists of candidates are submitted by the School Principals. Students at present overseas may be entered at the Education Directorate before March 23, 1989. The examinations will be held in early May.
- c) The Form 1 Scholarship Examination is offered for the last time in 1989. Thereafter it will be replaced by the Grade 6 examination. Note that Form 1 Students will compete for a maximum of ten(10) scholarship positions. Another ten(10) scholarship positions are offered for competition by Grade 6 students and shall be awarded separately from those offered to Form 1 students.

#### 2. UPPER AGE SCHOLARSHIP

Students in Form 4 are eligible to sit for the Co-operative Scholarship Testing Program. Provisional awards may be made on the result of these tests, to be confirmed subject to satisfactory completion of the Form 4 year, 1989. However any child who will be older than 17 years on December 31, 1989 will be awarded a Sholarship only under special circumstances. Registration forms have been distrubuted through the schools. Additional forms are available from the Education Directorate, but registration should be completed before March 23, 1989. The examinations will be held on Saturday May 6, 1989.

Students who are currently attending schools overseas as private students may sit for the appropriate examination if they meet the requirements above. These studentsmust return to Nauru in time for the examinations at their own expence. In the event of such a student being provisionally awarded a scholarship, the student will be required to provide documentary evidence of satisfactory completion of the school year before the end of December 1989.
