## ELECTORAL ACT 1965-1973 SECTION 16

## NOMINATIONS FOR BY-ELECTION

(Yaren Ditrict)

Intending candidates for by-election in the constituency of Yaren are advised that:-

- (a) Nominations can validly be made only <u>after</u> the Rolls have been closed (i.e. after Saturday, 30th September, 1989) and on or before Nomination day (i.e. on or before Saturday, 7th October, 1989)
- (b) Nomination papers may be handed to the returning Officer at Chief Secretary's Officer during Public Service hours from Monday, 2nd October, 1989 to Friday, 6th October, 1989, and between 8:00 a.m. and 1:00 p.m on Saturday, 7th October, 1989. To assist intending candidates, the Returning Officer will also be available in the Chief Secretary's Office on those days. Nomination will close at 1:00 p.m. on 7th October, 1989.
- (c) Nominations must be made in Form 6 of the Schedule to the Electoral Act 1965-1973 and signed by <u>at least</u> two Electors who are on the Roll for the Electoral District of yaren and by the candidate. The intending candidate must also be an Elector whose name is on the Roll for the Electoral District of Yaren. No nominations shall be valid unless they comply with the requirements of law.
- (d) Nomination Forms are available from the Chief Secretary's Office.
- (e) Candidates who have been duly nominated, and wish to withdraw their candidature may do so by notice in writing signed by them to the Returning Officer not later than 4:30 p.m. on Saturday, 14th October, 1989.
