REORGANISATION OF DIRECTORATE OF CIVIL AVIATION

IT IS NOTIFIED for general information that it has been decided to reorganise the existing Directorate of Civil Aviation in the Department of Island Development and Industry into two new Directorates, namely:-

- (1) Directorate of Civil Aviation; and
- (2) Directorate of Flight Operations,

each to be headed by a Director, directly responsible to the Civil Aviation Authority on all operational matters, with the Secretary for Island Development and Industry to function as adviser to the Authority and also the administrative head of the two Directorates.

Pending formal approval by the Minister responsible for the Public Service of alterations of classification, designation and reorganisation of positions currently established under the Directorate of Civil Aviation pursuant to Section 15 of the Public Service Act 1961-1979, HIS EXCELLENCY VINSON DETENAMO, M.P. Acting President and Minister responsible for the Public Service, has approved the establishment of one position of Director of Civil Aviation to head the re-constituted Directorate of Civil Aviation, and one position of Director of Flight Operations to head the re-constituted Directorate of Flight Operations. The establishment of these two positions, in place of the current position of the Director of Civil Aviation, is effective from 30th November, 1989.

Captain Barry Cranston has been appointed to the new position of Director of Civil Aviation, and Captain P.N. Reddy to the new position of Director of Flight Operations.
