> SUMMARY OF THE AUDITED REPORT OF THE NAURU PHOSPHATE ROYALTIES TRUST FOR THE YEAR 1988-89

### I. INTRODUCTORY

- Section 30, Subsection (2), Clause (c) of the Nauru Phosphate Royalties Trust Ordinance 1968 requires the Minister to publish or cause to be published a summary of the audited annual report of the Nauru Phosphate Royalties Trust in the Government gazette.
- 2. The following is a summary of the audited annual report of the Trust dated 14th December, 1989 for the financial year ended 30th June, 1989. A copy of the report has already been laid before Parliament.

### IV INVESTMENT POLICY

 Section 25 of the Nauru Phosphate Royalties Trust Ordinance, 1968 provides as follows:-

"25. Moneys standing to the credit of a fund shall be invested by the Trust-

- (a) in securities of, or guaranteed by, the Commonwealth or a State;
- (b) in such other securities, or in securities included in such other classes of securities, as the Administrator in Council approves;
- (c) on fixed deposit in a bank approved by the Administrator in Council; or
- (d) in such other manner as the Administrator in Council approves.
