CONSTITUTION OF NAURU ARTICLE 25 POST OF CHIEF SECRETARY OF NAURU

The Cabinet invites written applications for appointment to the Post of Chief Secretary of Nauru. The appointment will be made by the Cabinet under Article 25 of the Constitution.

DUTIES:

The Chief Secretary has such powers and functions as the Cabinet directs and as are conferred on him by the Constitution or by the law. He is concurrently appointed Public Service Commissioner and Secretary to the Cabinet. Under the Births, Deaths and Marriages Ordinance he is ex-officio, Registrar of Births, Deaths and Marriages. He may also be appointed Returning Officer under the Electoral Act 1965-1973.

The Chief Secretary is the Chief Policy Adviser to Cabinet and may expect to be required to advise the Cabinet on a wide range of matters, including particularly those relating to the organisation and management of the Public Service. He will be responsible for co-ordinating the work of Departments, if required by the Cabinet, and for ensuring the implementation of Government's policies.

The Chief Secretary will be responsible to His Excellency the President for the works of the Chief Secretary's Departments which includes all personnel matters within the Public Service. Under Article 68 of the Constitution, the Chief's Secretary is responsible for making appointments of persons to the Public Service, removing them from office and for disciplinary control over the Public Service.

QUALIFICATIONS:

A good standard of education, considerable administrative ability and an ability to communicate effectively are required for the sucessful applicant, who will also be expected to have had considerable experience at a high level of the workings of a government in an administrative position. A tertiary qualification in an appropriate discipline and experience in legal affairs would be welcome, but not essential.

At present A\$18,949 per annum (S 4)
