NAURU PHOSPHATE ROYALTIES TRUST PROPOSAL FOR

INVESTMENT IN BRAUHAASE - SOLOMON BREWERIES LTD.

<u>IT IS NOTIFIED</u> for general information that at its meeting held on 1st May, 1990, the Cabinet, pursuant to Section 25, subsection (d) of the Nauru Phosphate Royalties Trust Ordinance 1968, -

- Approved the Nauru Phosphate Royalties Trust investing in a joint venture in Solomon Breweries Ltd in the Solomon Islands, subscribing 60% of the equity (excluding the term loan and credit line) which is approximately A\$4,264,800, with the remaining 40% (A\$2,843,200) to be sharedamong Brauhaase, Guiness Brewery, Coca Cola, and the Commonwealth Development Corporation;
- Required the Trust to closely study the management contract, tax concessions available in the Solomon Islands, seeking of a commitment from the Solomon Island Government for repatriation
- of dividends and capital, study of the tax aspects of this investment in Solomon Island or in Australia, and negotiation of an equitable joint venture agreement with Brauhaase giving each party the right of first refusal for sale of shares;
- 3) Directed that the Trust shall finance the joint venture agreement, the management contract and other aspects of the investment proposal subject to the satisfaction of the Minister responsible for the Trust;
- Authorised and empowered the Minister responsible for the Trust to take any action as he may deem necessary or convenient to give effect to this Cabinet decision.

NAURU PHOSPHATE ROYALTIES TRUST ORDINANCE, 1968

SECTION 25

RECONSTRUCTION AND REFURBISHMENT OF THE

GRAND PACIFIC HOTEL, SUVA

IT IS NOTIFIED for general information that at its meeting held on lst May, 1990, the Cabinet has, pursuant to Section 25, subsection (d) of the Nauru Phosphate Royalties Trust Ordinance, 1968, -

- Approved the proposal of the Nauru Phosphate royalties Trust to enter into a joint venture arrangement with the ACCOR Group of France for the renovation and refurbishment of the Grand Pacific Hotel, Suva, at a total cost not exceeding F\$17.5 million, to be financed 40% (F\$ 7 million) equity and 60% (F\$10.5 million) as loan capital, with the 40% equity to be shared 70% by the Trust and 30% by the ACCOR Group. The Trust contribution required for this investment is F\$ 7 million.
- 2) The above Cabinet authorisation is subject to the following conditions:
 - a) The proposed capital structure of the joint venture should be amended to include most of the cost incurred by the Trust in acquiring the Grand Pacific Hotel in 1988 and F\$3 million should be added to the project cost and credited in favour of the Trust in its share of the total equity;
 - b) In the management contract to be negotiated with the ACCOR Group the Trust should endeavour to get the term of the contract reduced to an initial period of 10 years, and the Incentive Fee reduced from 10% of the gross operating profits to 7.5% of the gross operating profits; ,
 - c) The Trust shall not finalise and conclude arrangements in respect of the details of the equity/debt structure including credit to the Trust for its purchase of the hotel in 1988, final estimates of projects costs and financial projections, review of management contract, review of loan agreement, and any change of name of the hotel, except upon approvals by the Minister responsible for the Trust;
 - d) The Trust/the Government of Nauru may raise with the Government of Fiji the matter of favourable treatment for the Trust investment in Grand Pacific Hotel with a view to achieving favourable tax incentives, absence of exchange control restrictions of repatriation of dividends and capital, adequate access for the hotel to foreign exchange for purchase of imports etc, and tax immunity, if possible, on the dividends earned by the Trust from this investment.
- Authorised and empowered the Minister reponsible for the Trust to take action as he may find it necessary and convenient to give effect to this decision.
