: OTIC Australia is currently installing on Nauru a new IDR Earth Station Facility which will shortly be operational. Also the national/ international telephone switching equipment is to likely be replaced with a digital system using stored programme control techniques in the near future.

The Director is responsible for the control of revenue and expenditure within the Directorate of Telecommunications' sphere of operations, and is expected to advise the Secretary on all matters affecting general policy including annual estimates of financial revenue and expenditure.
