#### AIR NAVIGATION ACT 1971-1977

(SECTION 34)

#### AIR NAVIGATION (AMENDMENT) REGULATIONS 1991

IT IS NOTIFIED for general information that in exercise of the powers conferred on it by Section 34 of the Air Navigation Act 1971-1977 and all other powers enabling it in that behalf, the Cabinet has made the following Regulations:-

- 1. These Regulations may be cited as the Air Navigation (Amendment) Regulations 1991.
- 2. The Schedule to the Air Navigation Regulations 1973 is repealed and the following new Schedule is substituted therefor-

#### "SCHEDULE"

#### (Regulation 285)

#### FEES

ITEM NO. MATTER FEE

 For each certificate given under these Regulations where the applicant is other than the Republic or a person or body, corporate or unincorporated, acting on behalf of the Republic

Ten Dollars

2. For each theoretical examination or practical test of skill for the purpose of qualifying for a licence, certificate or rating under Division 4 of Part III, or under Part IV, of these Regulations.

Such amount, if any not exceeding 100 dollars as Authority specified by an Air Navigation Order."

#### AIR NAVIGATION ACT 1971-1977 SECTION 35(1)

#### AIR NAVIGATION (AMENDMENT) REGULATIONS 1991

IT IS NOTIFIED for general information that in exercise of the powers conferrred on it by sub-section (1) of Section 35 of the Air Navigation Act 1971-1977 and all other powers enabling it in that behalf, the Cabinet has made the following Regulations: -

- 1. These Regulations may be cited as the Air Navigation (Fees and Charges) Regulations 1991.
- These Regulations shall come into force on 1st day of August, 1991.
- 3. The owners or operators of all aircraft flying through the Nauru Flight Information Region shall be charged a fee in accordance with the Schedule to these Regulations.
- 4. The fee or charges shall be paid to the Civil Aviation Authority or any officer authorised by him.

#### SCHEDULE

#### MATTER

#### FEE/CHARGES

Air Navigation Charges on aircraft flying through the Nauru Flight Information Region.

The fee to be paid is calculated on the basis of distance flown in the FIR and the mass of the aircraft.

The formula for the calculation of the fee is -

R: N x \$3 x P

Where R is the fee payable in dollars.

Where N is the distance in nautical miles flown in the Nauru FIR divided by 50.

Where P is the factor shown grown below for the aircraft mass.

Where the aircraft mass is up to 35 tonnes P is 1.

where the aircraft mass exceeds 35 tonnes but does not exceed 99 tonnes P is 2.

Where the aircraft mass exceeds 99 tonnes but does not exceed 199 tonnes P is 4.
