ARTICLE 68 (3)

APPOINTMENT OF ACTING SECRETARY FOR HEALTH & EDUCATION

IT IS NOTIFIED for general information that Cabinet has, at its meeting held on 20th August, 1991, pursuant to Article 68, Clause (3) of the Constitution of Nauru, approved sharing of responsibility for the position of Secretary for Health and Education between MR ALLAN MALTBY, Director of Education - for education matters, and MR FELIX KUN, substantive Secretary for Island Development and Industry - for matters related to Health, with effect from 24th July, 1991. Matters relating to Health Department will be handled by Mr. Kun until the arrival of MR K.DEOURI EMIU, substantive Personal Secretary, or until the return of Dr. Keke to Nauru, whereupon the latter shall resume duties in the said position.
