#### ELEVENTH GENERAL ELECTION OF COUNCILLORS

#### NOMINATION DAY

The nomination of candidates shall be effected by delivering to the Returning Officer in his Office, Civic Centre, (1st Floor), Aiwo District, Nauru, in accordance with Form 'C' in the Schedule signed by two or more electors of the Council and by the candidate, not earlier than <u>22ND OCTOBER, 1991</u> and not later than <u>NOON OF</u> 1ST NOVEMBER, 1991.

The withdrawal of nominations can be made not later than noon of 1ST NOVEMBER, 1991.
