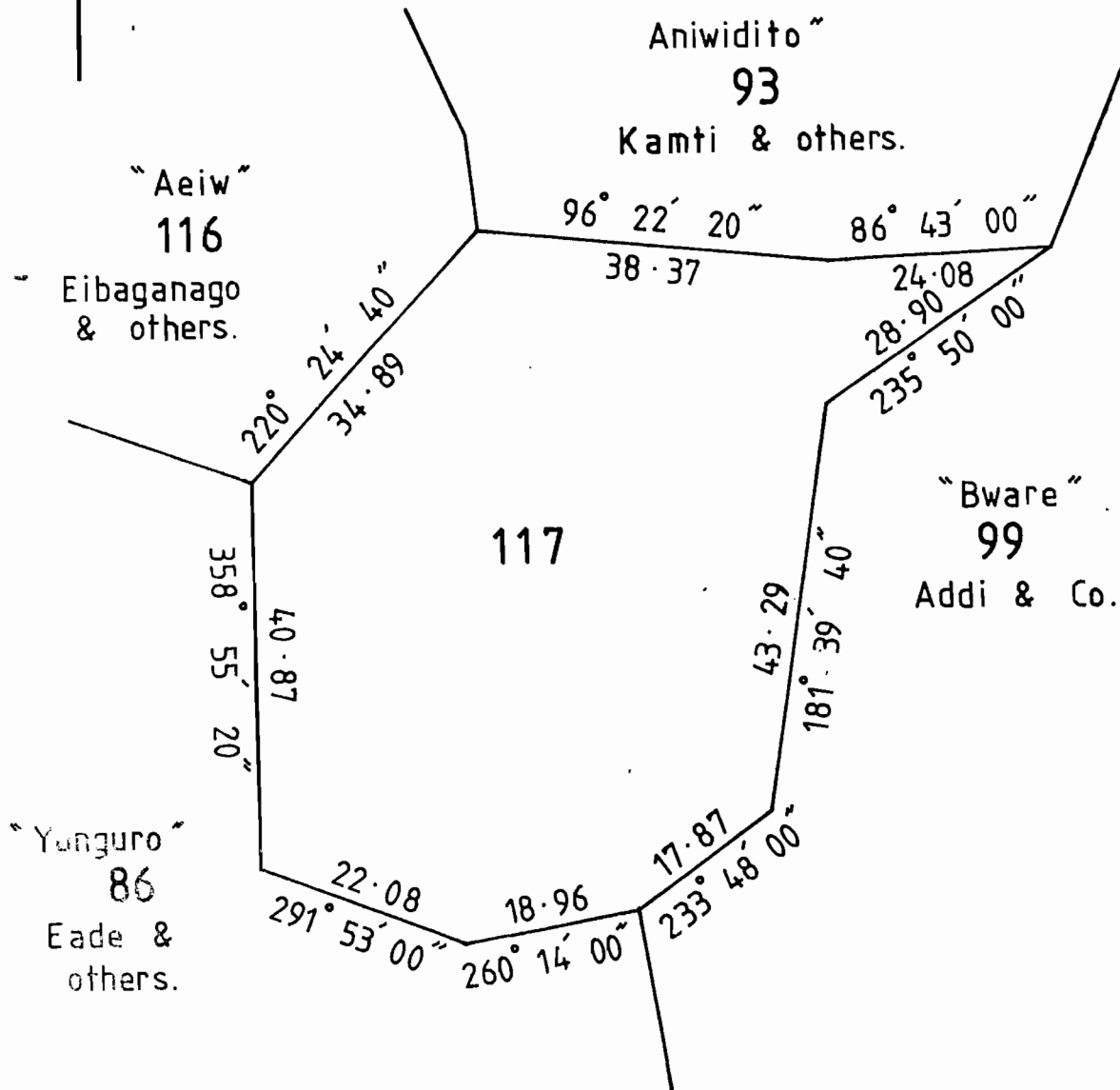

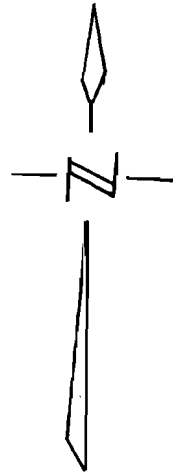
DISTRICT OF IJUW
